## 4. To receive the Accounts - Lynn MacQueen - Treasurer

The Itchenor Society is financially in a sound position as at 30th September 2024. The IS has funds of £8,133 plus £693.20 held in a pledge account having made a modest net income of £346.43 over the year.

Income for the year totalled  $\pounds 8,439, \pounds 4765$  from donations from the Itchenor residents the balance being income from events held by the Itchenor Society namely the Winter Lunch, the Summer Picnic and fete, donations from the Carol service.

The Itchenor Society aims include bringing a social element to the village, keeping residents informed of events and making charitable donations. The Itchenor Society has done that again the 2023/2024. Social events include Christmas Trees at the Hard and at the Church £883, a Summer Party of wine and canapés costing £572. Other social events are self funding by attendees. To enhance the communications within the village the Society has also developed a new website showing illustrating the beauty of Itchenor and giving details of events in the village costing £877 and has continued to deliver a newsletter to all households costing  $\pounds$ 1,030.

The Royal Marine Memorial Service commemorating the loss of 601 LCM Flotilla is supported by the Itchenor Society who supply service sheets and advertise the event costing £117.

I am pleased to say that the Itchenor Society has made donations of  $\pounds500$  to Chestnut Children's Hospice, a  $\pounds1,000$  donation to Stonepillow in the year under review but has also made further donations in October 2024 of  $\pounds500$  to Itchenor Memorial Hall and  $\pounds500$  to St Nicholas Church Itchenor.
